

# Cashback Terms and Conditions

## 1. High-Interest Cashback Categories

## 2. Category selection conditions:

- Each month, you can choose up to 3 categories.
- The chosen category can be changed starting from the 1st day of the new month.
- To continue earning cashback with the Yelo card, you must choose the categories every month.

### 3. Maximum monthly cashback amount:

Depending on the maximum limit of the selected categories, you can earn from 50 AZN to 60 AZN per month.

Upon reaching the maximum limit for a category, no cashback will be calculated for subsequent payments in that category. The maximum limit will be restored in the next month.

### 4. General information:

Cashback is only paid for transactions within the country.

Cashback is calculated and paid in the manat equivalent.

Cashback payment is not applicable for online transactions or purchases.

After the confirmation of the transaction, the accrued cashback is accumulated in the account. Later, this amount can be transferred to the card or used for payments in the Yelo Bank mobile application.

If cashback is not transferred to the Yelo card within 3 months, the accumulated amount will be automatically transferred to the customer's main Yelo card.

Cashback can be activated only on one card during the month. the card can be changed when choosing a new category in the following month.

Cashback can only be activated on Yelo Light, Yelo Premium, and Yelo Infinite cards.

Cashback is not paid for payments and purchases not related to the selected categories.

## The calculation of cashback does not apply to the following transactions:

Cash withdrawals from payment cards (ATM-Cash, Pos-Cash).

Card-to-card transfer operations (Card-to-Card, Visa Direct, Mastercard Money Send).

Internal transfers to electronic wallet balances (YandexMoney, etc.).

Online payments directed towards debt settlement (mortgage, consumer loans, installments, deferred payment of debts, etc.).

Online payments made through the Government Payment Portal (GPP) (utilities, state payments, taxes, customs payments, etc.).

Payments to mobile operators.

ASAN payments.

Public transport payments.

Gamble games.

All types of transactions conducted abroad.

When using online shopping and online services on websites.
